NADA Germany essentially contributes to preserving values in sports.

In July 2002, NADA Germany was founded with a festive act in the Old City Hall of Bonn and was recognised by the foundation supervisory authority on the 21st of November in the same year. Since then, it has been pursuing its valuable mission and supports athletes who pursue their sport with integrity. As a non-profit foundation under public law, which has been institutionally supported since January 2020, NADA Germany is an independent body. NADA Germany opposes doping in sports nationally and internationally alike. For the future of sport. For Germany as a sport nation. For clean athletes, for transparent success and honest results.

# DIALOGUE AND EXCHANGE ON EQUAL TERMS

LET'S TALK ABOUT - 12 years at NADA Germany have shown me that continuous communication between natural scientists, physicians,

lawyers, educators, ethicists and other fields of knowledge is key to the continued success of anti-doping work. The involvement of the central persons in anti-doping work, namely the athletes, is also essential for resolving the problems there are. Only through this exchange of experiences and the supporting professional discourse can we succeed in positioning and further developing the anti-doping work for the future. In 2022, NADA Germany also stepped up its efforts to involve the core target group at all levels of its work. In the run-up to, during and after the Olympic Games in Beijing, China, in February 2022, the support of athletes from the highest testing pool was a fundamental cornerstone for the implementation of the Remote Testing project to further develop the testing programme using Dried Blood Spot (DBS) samples. Since 2022, Athleten Deutschland e.V. has been a new partner of the TOGETHER AGAINST

DOPING (GEMEINSAM GEGEN DOPING) network. This means that in the future the athletes' point of view and voice will be increasingly brought into doping prevention, which is an enormous benefit for the network approach. Feedback from athletes was also an important component of new developments in doping prevention, such as the FAIR WERFEN game. Internationally, NADA Germany advocates for the involvement of athletes within the framework of the Declaration of Guiding Principles, which NADA Germany drafted with international partner organisations. The motto LET'S TALK ABOUT of the 2022 marketing campaign is continuous communication with athletes. I would also like to see this motto for future antidoping work, which can only succeed if dialogue and exchange take place on equal terms.

NADA Germany was audited by the World Anti-Doping Agency (WADA) in November 2022. The extensive preparation for the audit already started in April last year. NADA submitted all the necessary documents on time by mid-September 2022. The few comments made by WADA in the subsequent audit report will be implemented by NADA Germany within the specified deadlines. The number of criminal charges filed by NADA Germany for possible violations of the Anti-Doping Act was at a record level in 2022. The number of cases in sport law also increased again compared to previous years. There was an increase in cases due to the use of Substances of Abuse. The expansion of the network for state investigation authorities was an important part of NADA Germany's Intelligence & Investigations work. In 2022, NADA Germany initiated a training initiative for criminal doping law, the content and format of which is geared to the individual needs of the participants. The aim is to impart knowledge about the anti-doping regulations and its practical implementation as well as possibilities for cooperation between the individual stakeholders.

After 40 years in anti-doping work, 12 of them in a leading position at NADA Germany, it is time to put the responsibility for anti-doping work in other hands. This personal decision to leave NADA Germany has been made for some time and was agreed with the NADA Germany Supervisory Board at an early stage. I would now like to devote myself to other responsibilities and say goodbye to you.

I would like to thank all my colleagues with whom I have had the privilege of working during this long time, who have inspired me and who have treated me openly and fairly, without prejudice. Many of them have become good friends, both nationally and internationally.

As an athlete, I have experienced how important honesty is in sport

and I see with some concern the enormous challenges in the integrity issues of sport.

NADA Germany has evolved and achieved a lot during my tenure. However, there must be no standstill in stakeholder support here. The long believed security in questions of NADA Germany's funding is becoming topical again, and without permanent readjustment, the Foundation would lose its now high international reputation within a short period of time. All those responsible must be aware of this.

# FURTHER DEVELOPMENT OF ANTI-DOPING WORK

Since its foundation in 2002, NADA
Germany has been committed to
combating distortion of competition and
promoting fairness in sport. Over the
past 20 years, NADA Germany has grown
and made a name for itself in anti-doping
work. Today, it is internationally positioned and plays a leading role in discussions with other national anti-doping
organisations worldwide on the further
development of anti-doping work.

The 20th year of its existence was also an eventful year. In November 2022, NADA Germany was audited by WADA for two days on site in Bonn. The audit examined the implementation of WADA requirements in all core areas of German anti-doping work. The pleasing result of the WADA audit is an important assessment for the NADA Germany Foundation and makes it clear that NADA Germany is fully fulfilling its mission for clean sport in Germany.

With its two central pillars - doping prevention and the testing programme - NADA Germany continued to make a significant contribution to the preservation of values in sport in 2022. NADA Germany provided information on the dangers of performance manipulation through doping to specific target groups. NADA Germany's prevention programme TOGETHER AGAINST DOPING (GEMEIN-SAM GEGEN DOPING) reaches athletes with the media they use anyway. The e-participation app or the learning app "chunkx" are just two examples of the innovative programme that meets young athletes at eye level.

At the same time, the prosecution of doping violations is of great importance for the credibility of sport. The further development of the testing programme is a central concern of NADA Germany and was advanced in 2022, especially in the area of Dried Blood Spot (DBS) Remote Testing with the support of athletes.

NADA Germany's employees are committed to clean sport and work wholeheartedly to support all athletes who want to practice their sport fairly and without doping manipulation. NADA Germany thus makes an indispensable contribution in the service of clean athletes to uphold the values of sport. The Supervisory Board supports the Executive Board and the NADA Germany team in maintaining this high level of anti-doping work in Germany.

This annual report documents the manifold achievements of NADA Germany, for which the Supervisory Board would like to express its appreciation to the two Executive Board members Dr. Andrea Gotzmann and Dr. Lars Mortsiefer and their staff, who lead them with the ideal combination of doping analysis and sports law expertise. On behalf of the entire Supervisory Board, we say thank you and wish NADA Germany continued success.

# COMPLIANCE AUDIT BY THE WORLD ANTI-DOPING AGENCY



NADA Germany was audited by the World Anti-Doping Agency (WADA) in November 2022. As part of WADA's compliance requirements, NADA Germany was audited for compliance with the World Anti-Doping Code (WADC) and the standards. The aim of this compliance audit, to which all anti-doping organisations are subject, is to ensure that anti-doping rules and programmes are applied and implemented consistently and effectively in all sports and all countries.

NADA Germany's compliance audit assessed all areas (governance, testing, prevention, intelligence & investigations, results management, data protection and medicine).

The audit report highlights the strengths of NADA Germany and its anti-doping programme. In its very positive report, the WADA audit team notes that NADA Germany has a well-functioning, effective and focused anti-doping programme implemented by highly committed, experienced and passionate staff.

NADA Germany has well-documented

policies, processes and procedures.
The expertise and experience of the staff in all areas is highlighted. In particular, NADA Germany's prevention work is commended in the report. The WADA audit team encourages NADA Germany to continue to contribute its experience internationally.

The few suggestions for improvement made by WADA concern, among other things, the risk assessment of sports by NADA Germany, the regulations of Therapeutic Use Exemptions for non-test pool athletes and individual adaptations of the German standard for results management and disciplinary proceedings to the WADA specifications.

NADA Germany will implement all comments and measures on time and is WADC compliant.

# TESTING PROGRAMME

#### **Further development**

In order to further develop the Dried Blood Spot (DBS) test method, NADA Germany researched additional possible applications together with the Institute for Biochemistry at the German Sport University Cologne and the company Sportradar. A total of 24 athletes from the Registered Testing Pool (RTP) from various sports such as bobsleigh, fencing, football, weightlifting, cycling, luge, rowing, triathlon, skiing and volleyball took part in the project. 102 DBS samples were taken using a new technical remote testing solution in the form of an app. NADA Germany will present the results of the research project to WADA in order to also enable the possibility of remote sampling as a supplementary tool in the future.

2022 was the first year in which NADA Germany carried out continuous Dried Blood Spot testing. In autumn 2021, WADA made it possible to use the DBS method as part of regular testing.

#### Testing of Ukrainian athletes

In coordination with the National Anti-Doping Centre of Ukraine,

NADA Germany took over the testing of Ukrainian athletes who fled from Ukraine to Germany due to the Russian war of aggression.

#### **Further testing activities**

At the European Championships in Munich, NADA Germany took over the coordination of all doping tests.

Another major event took place with the Finals in Berlin, where NADA Germany carried out the test implementation.

Within the framework of a cooperation with the new European Football

League (ELF), NADA Germany carried out testing throughout Europe.

#### **Medication controls for horses**

NADA Germany and the German
Olympic Committee for Equestrianism
(DOKR) have extended their
contract to carry out medication
controls on horses in training for
another 3 years. This means that
NADA Germany will continue to
check horses out of competition in
preparation for the 2024 Summer
Olympic Games in Paris, France.

#### Dealing with COVID-19

In 2022, NADA Germany continued to take into account the requirements of the federal government, the federal states and, in the case of tests abroad, the requirements of other countries, as well as the guidelines of WADA, for the preparation of its hygiene and infection protection concept. The concept was regularly adapted due to the constantly changing pandemic situation. For example, before and during the Olympic Games in Beijing at the beginning of 2022, a 2G+ regulation and FFP-2 mask requirement still applied for doping control staff. After the end of the general mask obligation, the wearing of a mask is still recommended, but is no longer obligatory.

# **LEGAL MATTERS**

#### **Results management and** Sanctioning procedures

The number of filing failures and missed tests was at a record level in 2022. NADA Germany initiated a total of 745 hearings with 505 identified filing failures and missed tests were carried out in 2022. Since January 2021, all athletes who belong to the National Testing Pool (NTP) and are found to have a filing failure/missed test are upgraded to the higher Registered Testing Pool (RTP). 285 athletes were upgraded to a higher testing pool in 2022.

#### 79 possible violations

In 2022, NADA Germany investigated 79 cases of possible anti-doping rule violations. In 57 cases, NADA Germany initiated a results management procedure. In 2022, NADA Germany registered an increase in possible violations due to the use of addictive substances, such as tetrahydrocannabinol or cocaine. NADA Germany determined 25 sanctions (sanction

notice/decision) and conducted 5 proceedings before the German Court of Arbitration for Sport (DIS). 3 CAS proceedings were concluded.

#### **Data protection**

At the EU Anti-Doping Conference in Prague in November 2022, under the presidency of the Czech Republic, Dr Lars Mortsiefer presented the measures in the area of data protection in German anti-doping work. Data protection and data security are important rights of athletes and cornerstones of anti-doping work. Therefore, it is crucial that anti-doping organisations adequately protect the personal data they collect, while complying with the requirements of applicable data protection law and thus maintaining the trust of those involved in organised sport in the long term.

With regard to the publication of sanction decisions, NADA Germany continues to communicate with the North Rhine-Westphalia State Commissioner for Data Protection and

Freedom of Information (LDI NRW). NADA Germany is working together with other National Anti-Doping Organisations (especially in Europe) and WADA to establish uniform data protection standards in anti-doping work in a legally secure manner.

# INTELLIGENCE & INVESTIGATIONS

#### **Global network**

In cooperation with WADA, other National Anti-Doping Organisations, international federations and INTERPOL, the international network in the field of Intelligence & Investigations 2022 was further expanded. In order to harmonise and strengthen investigations in connection with doping in sport worldwide, NADA Germany, as a founding member, has been part of the international Anti-Doping Intelligence & Investigations Network (ADIIN) and the Sport Human Intelligence Network (SHIN) since 2017. The aim of these groups is to support anti-doping organisations in conducting investigations and to identify and promote best practice investigation standards. In 2022, NADA Germany was on site at the exchange in Paris, France.

#### National network

The continuous and intensive exchange with public prosecutors' offices and investigators from customs, the Federal Criminal Police Office (BKA) and individual police stations strengthens the joint approach and increases the effectiveness of anti-doping work in

all areas. Also in 2022. NADA Germany met for two exchange meetings with public prosecutors' offices, BKA and customs. NADA Germany receives investigative support from the company Sportradar. The cooperation was extended for another three years at the end of 2022 and is carried out in strict compliance with data protection requirements. Sportradar supports NADA Germany primarily in the areas of social media monitoring and analyses, due diligence & risk and compliance analyses as well as network research and case analyses. In 2022, NADA Germany received further information from Sportradar in 26 cases.

The whistleblower system SPEAK UP (SPRICH'S AN) continues to be an important tool in the Intelligence & Investigations work. Since its establishment, NADA Germany has received around 240 tips. All tips are valuable and initiate investigations at NADA Germany. Around ten percent of the tips led to a positive analysis result and/or a possible violation of anti-doping regulations.

## Training and Research Initiative in Criminal Law on Doping

NADA Germany, in cooperation with the Director of the District Court Bühl, Dr Sebastian Wußler, and the Federal Institute for Sport Science (BISp), has continued to institutionalise the further Education and Research Initiative in Criminal Doping Law (FIDoS). FIDoS is an independent initiative of experts from NADA Germany, judicial, police and customs authorities and WADA-accredited laboratories to provide those involved in anti-doping work with knowledge about doping law and its practical implementation as well as possibilities for cooperation between the individual participants through a training programme geared to individual needs. The training programme is aimed in particular at police and customs officers, judges, public prosecutors, athletes and association officials. The seven different lecture modules can be combined individually and flexibly. The kick-off event took place in May 2023.

# **MEDICINE**

#### Further education and information

Online events for medical staff have become an integral part of the work of the Medical Department. Among other things, the staff gave digital lectures at the medical conference of the National Paralympic Committee Germany and the German Athletics Association. A meeting of the Basket-Docs took place in Cologne. Furthermore, the Medical Department organised training for the team physicians of Rugby Germany, the German Billiards Union and the German Dart Association.

The Medical Department was also involved in the #NADAinformiert web seminar series initiated in 2022 with a lecture on Therapeutic Use Exemptions and a lecture on the WADA Prohibited List. The annual conference of the Verbandsärzte Deutschland e.V. and the German Olympic Sports Confederation (DOSB) conference "Sports Medicine in Elite Sport", which were attended digitally in 2022, are permanent fixtures among the medical training courses.

The digital NADAmed database again received a large number of search now contains approx. 2,000 frequently prescribed or requested drugs that are approved or registered in active ingredients. The sample list of permitted pharmaceuticals published by NADA Germany's Medical department lists permissible drugs according to ailments and thus offers a simple aid for athletes in the event of illness. The informative translation of the WADA Prohibited List 2022 rounded off the information offered.

#### Research

The Medical Department is responsible for supporting research projects of the two German WADA-accredited anti-doping laboratories. In 2022, among other things, research projects were supported to improve detection methods for substances that influence muscle growth and to investigate ethanol as an interfering factor in the doping analysis of blood samples.









# **COMMUNICATION &** MARKETING

#### Digital public relations

In 2022, a switch between live and online communication was possible. Digital formats from the pandemic period were continued as an important part of NADA Germany's communication. In February 2022, NADA Germany digitally presented the measures to prepare for the Olympic Winter Games in Beijing. The annual press conference in May to present the anti-doping activities in 2021 also took place digitally. The workshop for anti-doping officers in August was used for an update of the target group. At the digital journalists workshop in October 2022, Léa Krüger (Athleten Deutschland e.V.), Prof Andrea Petroczi (Kingston University London), Marc Vouillamoz (Union of European Football Associations, UEFA) and Dr Andrea Gotzmann discussed about the topic doping prevention.

NADA Germany also offers various training opportunities for press representatives on the topic of anti-doping. The #NADAinformiert web seminar series was newly established

as part of the training opportunities. Since June 2022, NADA Germany experts have been explaining specific anti-doping topics in a monthly online session. The web seminar series is open to all interested parties.

Since January 2022, NADA Germany has again been sending out a newsletter for all interested target groups, informing them about current topics in anti-doping work. Answering daily enquiries, organising interviews and publishing news on the website and in social media rounded off the public relations work.

#### Initiative for clean sport

In 2022, athletes were the focus of the initiative for clean sport. The campaign "LET'S TALK ABOUT" aims at a dialogue with athletes. Important values of sport were addressed in a poster campaign. Athletes entered into direct dialogue with NADA Germany on topics that are important to them. For the first time since the start of the pandemic in 2020, NADA Germany was again present at events with its live tool. At the European

# **EDUCATION**

#### **Achieving more together**

For NADA Germany, education work means educating those who are at the centre of sporting events: Athletes are enthused about clean sport, informed and accompanied, and their environment is activated through targeted education measures. Doping education is a central component of the anti-doping programme and has been firmly anchored in WADA's international regulations since 2021 with its own standard for doping education. Based on the NADC and the standard for education, NADA Germany implements the prevention programme TOGETHER AGAINST DOPING (GEMEINSAM GEGEN DOPING) within the framework of the doping prevention plan valid for Germany.

For doping education to succeed, the involvement of all those involved in sport is essential. The network approach is used to anchor the education services in the sports structures in close partnership with stakeholders such as umbrella organisations, state sports federations and state professional associations.

The aim of TOGETHER AGAINST
DOPING is to achieve more
education for the core target group
in a coordinated and organised
manner. Members of the TOGETHER
AGAINST DOPING network have
the opportunity to benefit from
the experience of other network
participants, to initiate joint projects
and to help shape the development of
anti-doping education in Germany.

Especially through the active participation and commitment of many different institutions and individuals, the programme today makes a decisive contribution to clean sport. Together, this can achieve more for education work in Germany.

On its own website for the area of anti-doping education, NADA Germany has compiled relevant information on topics such as the communication of values, information for athletes of different ages as well as useful knowledge for the athletes' environment in a way that is appropriate for the target group.

With its integrated learning approach, NADA Germany links e-learning via smartphone app on the one hand. On the other hand, it organises workshops, trainings and other presence formats. Further offers are the target group brochures, teaching materials and helpful tools for the everyday sporting life of all participants. The brochure for coaches was revised in 2022 and has since been available as the COACH brochure.

## Commission education newly constituted

On 25 January 2023, NADA Germany's newly constituted education Commission held its first digital meeting. Dr Marc Wonneberger (photo right) from the Federal Institute of Sport Science (BISp) was appointed by the NADA Germany supervisory board as chairman of the committee, which works on a voluntary basis. The expertise represented in the commission from the fields of education, psychology, coach education and athlete knowledge advises the Education Department on the target group-oriented focus of doping education.



#### TOGETHER AGAINST DOPING -Networking Event

For the sixth time, NADA Germany in cooperation with BISp invited representatives of national sports federations, state sports federations and associations, regional associations, large clubs and other institutions to the TOGETHER AGAINST DOPING network event in Cologne. The agenda of the two-day event in the RheinEnergie Stadium included keynote speeches by invited experts and a productive exchange between the represented institutions as multipliers of doping education in Germany.



#### E-Participation project

In cooperation with the BISp and Athleten Deutschland e.V., NADA Germany has set up a project for the participation of competitive athletes in the content of doping education. A total of 329 athletes took the opportunity to vote in a survey via app in which areas they would like more information or support. Almost half of the participants needed more information on nutritional supplements. The project partners have taken this as an opportunity to initiate an additional education project.



## FAIR THROW (FAIR WERFEN) - Who wins without tricks?

In order to bring value-based decision-making skills closer to the younger target group of school age, NADA Germany has developed the new game FAIR THROW and distributed it for the first time in 2022. FAIR THROW offers young athletes a playful, informal first contact with the topic of anti-doping. Guided FAIR THROW focuses on the individual experiences and decisions of the players. Guided by a teacher or a NADA Germany employee, FAIR THROW focuses on the individual experiences and decisions of the players.



#### New e-learning course football

In cooperation with the German Football Association (DFB), NADA Germany has created two new e-learning courses which, like NADA Germany's existing courses, can be completed via the microlearning app chunkx. The project was realised in connection with the HatTrick support programme of the Union of European Football Association (UEFA).



#### **Training of freelancers**

In order to be able to carry out all training courses, workshops and information stands within the framework of anti-doping education throughout Germany, NADA Germany currently has a pool of approximately 60 freelancers. The freelancers were also trained by NADA Germany several times in 2022 in terms of content and didactics in order to ensure the high quality of the education measures.

# HUMAN RESOURCES, FINANCE & CONTROLLING

## Business development and financial situation of the Foundation

Since the 2020 financial year, NADA
Germany has been funded by the
Federal Ministry of the Interior
and Community (BMI) within the
framework of institutional funding.
This type of funding ensured
financial planning security for
NADA Germany in 2022 as well.

In the course of the conversion process to institutional funding, the necessary procedural adjustments were made on an ongoing basis, applying the General Auxiliary Conditions for Grants for Institutional Funding (ANBest-I).

The Federal Government contributed to NADA Germany's operational business with a grant of 6,02 million euros. At the beginning of 2022, the Federal Government was in so-called provisional budget management. It was not until the beginning of the third quarter that NADA Germany received the final, unrestricted notice of approval for the full amount of the grant. Until then, NADA Germany

initially had only 45% of the grant amount at its disposal to fulfil only absolutely necessary legal obligations.

The financial contribution of the federal states to the financing of doping prevention was 622 thousand euros.

Sport contributed 630 thousand euros.

The total budget of the operative business amounted to about 12,07 million euros. Included are federal funds of about 2,26 million euros, which were forwarded to the WADA-accredited laboratories in Cologne and Kreischa to finance research and analysis.

The effects of the global COVID 19 pandemic were still clearly felt in the world of sport at the beginning of 2022. However, the situation eased considerably in the course of the year. Starting with the Winter Olympics in Beijing at the beginning of 2022, almost all sports federations and organisers of major sports competitions intensified their planning and event activities again. Parallel to this, NADA Germany also increased its activities at on-site events.

As of 31 December 2022, NADA Germany had 34 full-time employees, ten part-time employees and four persons in marginal employment.

#### **Table Explanation**

In compliance with the General Auxiliary Conditions for institutional funding, NADA Germany used the profit carried forward in part to finance the operational business and thus to cap the net loss for the year. NADA Germany thus achieved a balanced annual result in terms of income and expenditure in accordance with budgetary law.

The audit of NADA Germany's annual financial statements was conducted by an external auditor (Ebner Stolz). This audit did not lead to any objections for the year 2022.

# INTERNATIONAL COOPERATION

#### **Guiding Principles**

Together with a group of leading anti-doping organisations, NADA Germany has proposed Guiding Principles as a basis for international anti-doping work. Continuous development and improvement of the anti-doping system is crucial in order to be able to act in a relevant and effective manner. Through coordinated and joint efforts, the global movement for doping-free sport is to be strengthened in many ways in order to be better equipped for the future. Key components of the Guiding Principles address athlete involvement, effective education, ethical foundations and principles of good governance.

#### International visit

In 2022, NADA Germany once again welcomed international visitors to its office. Representatives of the U.S. Anti-Doping Agency (USADA) came to Bonn in May for an exchange meeting on international cooperation. The topic of doping education was on the agenda during the partnership visit of experts from the Kazakhstan

Anti-Doping Agency (KAZ NADC) in June. The exchange relationship with Kazakhstan has existed for several years. In July, NADA Germany welcomed representatives of the Japanese Anti-Doping Agency (JADA) to Heussallee. The central topic of the discussion was the implementation of intelligence and investigation work in both countries. The focus of the visit of the Korean Anti-Doping Agency (KADA) in September was the implementation of the testing programme, in particular the application of the Dried Blood Spot (DBS) test as part of the doping control routine. As part of the planning and preparation for the next Summer Olympic Games, which will take place in Paris in 2024, colleagues from the French Anti-Doping Organisation (AFLD) were guests. NADA Germany received a visit from Ukraine in December. The focus was on supporting Ukrainian athletes and the National Anti-Doping Centre of Ukraine (NADC). At the request of WADA, NADA Germany had agreed to include Ukrainian athletes who are in Germany in its control system.

#### International conferences

For the exchange, but also for the acquisition and transfer of knowledge, NADA Germany participated in various anti-doping conferences in 2022. Dr Andrea Gotzmann spoke about the further development of the testing programme at the digital CHINADA symposium. At the USADA symposium, the Chairperson of the NADA Germany's Executive Board explained the implementation of remote testing in the area of DBS samples. At the Play the Game conference in Odense, Denmark, the focus was on the topic of athlete involvement within the framework of the research project on the implementation of remote testing.

#### 1. SUMMARY

# 1.1. Information on the duly appointed data protection officer

Hereby I certify as the externally appointed data protection officer of the National Anti Doping Agency of Germany an existing data protection management system as required by the applicable Federal Data Protection Act and the European Data Protection Regulation (EU-DSGVO / GDPR).

I also confirm that I have fulfilled my duties as data protection officer in accordance with the requirements of according to Art. 39 DSGVO:

- Informing and advising the controller or processor and the employees who carry out processing operations, with regard to their obligations under the data protection regulations;
- Monitoring compliance with data protection rules as well as the controller's or processor's personal data protection policies, including assigning responsibilities, raising awareness and training employees involved in processing operations and carrying out checks in this regard;
- Advice, upon request, in relation to the data protection impact assessment and monitoring of its implementation in accordance with Art. 35 GDPR;
- Cooperation with the supervisory authority; and
- Acting as a point of contact for the supervisory authority on issues related to the processing, including prior consultation pursuant, to Art. 36 GDPR, and, where appropriate advice on all other issues.

The National Anti Doping Agency of Germany has undergone an admission on the basis of BSI Basic Protection, and has implemented the recommendations for action. In particular, the following areas are implemented within the scope of the data protection management system (DSMS):

- Order processing according to Art 28 DSGVO / §62 BDSG
- Procedure directories according to Art 30 DSGV0 / §70 BDSG
- Appropriate information procedure according to Art 15 DSGVO / §34 BDSG
- Technical organisational measures according to Art 32 DSGV0 / §64 BDSG
- Data protection guideline
- Data protection employee sensitisation

#### 2. STATUS QUO OF THE CONTROLLER

The directory of processing activities keeps procedural directories in conformity with DSGVO Art. 30 in the areas of

- ▲ IT
- Administration / Secretariat
- · Accounting department
- Office communication / office / writing department

Further procedure directories are being compiled. In this respect, there is a directory of processing activities, that covers this.

Existing procedure directories are maintained on an ongoing basis.

For 2023, the next review process of the documented procedure directories must be planned with the respective department heads and coordinated and carried out with the Data Protection Officer.

## 2.2 Fulfilment of information obligations

The data protection information for the website is updated and adapted in accordance with the specified legal requirements.

#### 2.3 Data deletion policy

Personal data will be deleted or blocked after the legal basis has ceased to exist or if consent is revoked, depending on technical feasibility. Deletion requirements are set out in the register of processing activities. The implementation of deletions is organised. The documentation of the organisation in a deletion concept is recommended and is to be coordinated with the Data Protection Officer for the year 2023.

## 2.4. Data protection concept (Art. 5 (2) GDPR)

The data protection concept of the controller aims to present the data

protection aspects in a summarised documentation. It can also be used as a basis for data protection audits, e.g. by clients in the context of commissioned processing. This is not only to ensure compliance with the European General Data Protection Regulation (GDPR), but also to create evidence of compliance.

The protection of personal data is a high priority for the controller. The GDPR is intended to protect the right to informational self-determination. As a manifestation of the general right of personality under Article 2 (1) of the German Constitution in conjunction with Article 1 (1) of the German Constitution, this fundamental right is the right of the individual to determine for himself or herself the disclosure and use of his or her personal data. This requires regulations on the handling of data. Personal data must be handled confidentially. The data protection concept helps with the organisation and procedure of data protection. With the given regulations, the employees gain security in dealing with personal data. They should use it as a guideline; it shows which requirements must be met. NADA Germany's data protection concept for 2023 must be finalised by the end of Q2 2023.

## 2.5. Safeguarding the rights of data subjects (Chapter III GDPR)

The appropriate access procedure is organised, the data storage locations and contact persons have largely been identified, the process has been established and the template for any access requests has been drawn up. Requests for information continue to be answered appropriately.

# 2.6. 2.6 Data security incidents (Art. 33 DSGVO)

In the reporting period from 01.01.2022 to 31.12.2022, there were no reportab-

le data security incidents or IT security incidents that had to be reported to the competent supervisory authority. The escalation plan in the event of a possible reportable data protection incident must be written down for the year 2023 at the controller.

## 2.7. Conduct data protection awareness training (Art. 32 GDPR)

Employees are regularly sensitised on data protection. Future awarenessraising sessions will continue to take place at the controller's premises or through video conferences.

## 2.8. Technical and organisational measures (Art. 25 and 32 GDPR)

The responsible person has implemented technical and organisational measures, taking into account the state of the art, the implementation costs and the nature, scope, circumstances and purposes of the processing, as well as the varying likelihood and severity of the risk to the rights and freedoms of natural persons. The existing documentation of these measures taken is sufficient, as these were subject to a review in 2022 and, where applicable, correspond to the state of the art.

#### 2.9. Order processing agreements

All relevant service providers in terms of commissioned processing pursuant to Art. 28 of the GDPR were contractually fixed and randomly audited. New processors are notified to and reviewed by the Data Protection Officer prior to commissioning.

# 2.10. Review of the data protection impact assessments pursuant to Art.35 of the GDPR

Data protection impact assessments were carried out in 2021 for the following procedures:

- ADAMS System
- RTS (Remote Testing System)

All identified risks for data subjects were recorded and it was subsequently determined that the protective measures taken lead to sufficient mitigation of the risks. These risks were assessed based on the probability of occurrence and the severity of the impact. Based on the technical and organisational measures taken, with detailed consideration of the data protection risks to the athletes' personal rights, an acceptable residual risk was determined.

Thus, even after completion of this assessment, it was determined that, pursuant to Art. 36 of the GDPR, no prior consultation of the supervisory authority had to take place and that the procedures could be used in a data protection-compliant manner. These data protection impact assessments must be subject to a possible review in 2023 in consultation with the data protection commissioner.

## 2.11. Prior data protection checks of essential processes

The Data Protection Officer will be requested as necessary, for example in the case of

- Extensions to the infrastructure
- operation of IT solutions
- data protection requests from athletes
- data protection enquiries from employees
- data protection requests from other third parties
- ....

# 3. Further training and certificate of competence of the data protection officer

The data protection officer, Dr. Ralf Schadowski, is the external data protection officer of the data controller. He is personally ISO 17024 certified in the area of data protection and thus continuously monitored. He supports the data protection officer with 35 data protection specialists from his team, who individually also have up-to-date training levels.

## 4. Tasks and measures for the reporting year 2023

In 2023, the data protection measures will be continued at the data controller. This includes the following tasks and measures, summarised from the report, which must be fulfilled and implemented in this year:

- Review of the directories of processing activities
- Review of the website and adjustments to the privacy policy
- Review and update of the fair disclosure procedure process
- Ongoing review of new software or processing activities based on data protection briefs/DSFA
- Ongoing review of new processors
- Continuous recording and documentation of data protection incidents
- Continuous recording and documentation of requests for information and deletion
- Implementation and monitoring of data protection sensitisation
- Finalisation of the data protection concept
- Coordination of documentation of the deletion concept
- Documentation of the escalation plan in the event of a possible data protection incident

The controller must coordinate and implement these tasks together with the Data Protection Officer for 2023 in order to comply with its accountability obligation under Article 5(2) of the GDPR. Failure to comply with the

accountability obligation carries a high risk of fines being imposed on the controller by the supervisory authorities, the publication of which may also result in a high loss of image for an organisation such as NADA Germany.


