NADA Germany essentially contributes to preserving values in sports.

In July 2002, NADA Germany was founded with a festive act in the Old City Hall of Bonn and was recognised by the foundation supervisory authority on the 21st of November in the same year. Since then, it has been pursuing its valuable mission and supports athletes who pursue their sport with integrity. As a non-profit foundation under public law, which has been institutionally supported since January 2020, NADA Germany is an independent body. NADA Germany opposes doping in sports nationally and internationally alike. For the future of sport. For Germany as a sport nation. For clean athletes, for transparent success and honest results.

# **CONSTANT OPTIMISATION IN NADA GERMANY** FOR CLEAN SPORT

The past year was extremely exciting for NADA Germany. In July, Dr Andrea Gotzmann resigned as the longstanding Chairwoman of the Executive Board. The Supervisory Board appointed us as the new Executive Board duo last autumn and in February 2024. With our many years of experience in antidoping work, we stand for continuity and expertise for both the NADA Germany team and all of NADA Germany's target groups, but also for new approaches and further development. We will continue to stand up for clean athletes both nationally and internationally.

The current revision of the World Anti-Doping Code 2027 (WADC27) is an important building block on the road to global fairness and equal opportunities. NADA Germany will continue to focus on the ongoing development of the two-pillar model - doping education and testing programme.

The TOGETHER AGAINST DOPING network was a central element of NADA Germany's education work last year. The aim is to reach young athletes as a primary target group at an early stage via the structures of the network and to inform them jointly about the sport of tomorrow and, if possible, before the first doping test by offering a wide range of educational programmes at eye level. The expansion of TOGETHER AGAINST DOPING will continue to be one of NADA Germany's main tasks in the future.

NADA Germany has expanded its range of doping testing measures in 2023. In collaboration with the Institute of Biochemistry at the German Sport University Cologne, innovative analysis methods were used and the so-called digital matrix of samples was analysed to detect doping. At the same time, NADA Germany has significantly increased the use of the new Dried Blood Spot Matrix to facilitate the testing process.

NADA Germany has also raised its international profile by taking over the management of the World Anti-Doping Agency's (WADA) Independent Observer Programme at the European Games in Krakow 2023 and by working on the international testing recommendations for the Olympic and Paralympic Games in Paris 2024. International dialogue and exchange is essential for the further development of anti-doping work.

Findings from Intelligence & Investigations work and cooperation with state investigative authorities make a significant contribution to the protection of clean sport. In 2023, NADA Germany was part of an EU-funded WADA project to strengthen Intelligence & Investigations work in Europe.

For us, the focus of all NADA Germany measures is on clean athletes. Regular dialogue and the involvement of core target groups in anti-doping work are high importance for us.

We are very much looking forward to tackling the foundation's future tasks and goals together with a highly committed NADA Germany team of antidoping experts and with the support of our stakeholders.

# **CONTINUITY IN THE ANTI-DOPING WORK**

In 2023, there was a change in management. After almost twelve years as Chairwoman of the Executive Board, we bid farewell to Dr Andrea Gotzmann at her own request. She has significantly shaped the work of NADA Germany and played a key role in its development. On behalf of the entire Supervisory Board, we would like to thank her and wish her all the best for the future.

In September 2023, the Supervisory Board unanimously appointed Dr Lars Mortsiefer as the new Chairman of NADA Germany's Executive Board. He has been a member of NADA Germany's Executive Board since 2011 and is Head of Legal Matters at NADA Germany. He will now contribute his many years of experience to the NADA Germany Executive Board as Chairman of the Executive Board.

It was also possible to complete the Executive Board in a timely manner. At the end of February 2024, the Supervisory Board unanimously appointed Dr Eva Bunthoff as a member of the Executive Board. Dr Bunthoff has been Head of Communications and Marketing at NADA Germany since 2013. In future, Dr Bunthoff will also take over the management of NADA Germany's Testing Programme.

The new Executive Board therefore has a great deal of experience and expertise and will continue the anti-doping work in Germany at a high level together with the entire NADA Germany team. The prompt completion of the Executive Board also seemed necessary because 2024 will be a " Super Sport Year" with many major international sporting events in Germany and, last but not least, the Olympic and Paralympic Games will take place in neighbouring France. NADA Germany will accompany the clean athletes on their way to the major sporting events. In-competition testing as well as unannounced out-ofcompetition testing are part of an effective anti-doping programme that protects the rights of clean athletes and ensures equal opportunities.

The focus was already on the further development of the doping testing programme in 2023. At the same time, NADA Germany team contributed its experience from Germany internationally, including at the European Games and in the Pre-Games Testing Task Force for the Olympic and Paralympic Games. With this commitment, NADA Germany is intensifying its efforts to promote equal opportunities worldwide.

The sustainable network approach also enables athletes to benefit from NADA Germany's TOGETHER AGAINST DOPING education programme over the course of their sporting careers, their environment is sensitised to clean sport and associations and clubs from organised sport firmly anchor doping education in their own institutions and communication. The appropriate target group approach was further developed with the relaunch of the doping education website, new e-learning channels and a Pixi book for children aged four to seven.

NADA Germany remains committed to fair and doping-free sport. NADA Germany's Supervisory Board will continue to do its part to ensure that the management and the NADA Germany team have the necessary foundations so that NADA Germany can continue to promote and support the values of sport in the future.

# TESTING PROGRAMME

### Further development

The use of the Dried Blood Spot (DBS) matrix as a further sample option was significantly increased in 2023. More than 550 DBS samples were taken and analysed for the first time.

In collaboration with the Institute of Biochemistry at the German Sport University Cologne, NADA Germany analysed the digital matrix of long-term stored samples for the first time. The digital matrix of samples from 2019 and 2020 was analysed for the substances JTV-519, Tirasemtiv and Reldesemtiv of substance class S0. of the World Anti-Doping Agency (WADA) Prohibited List. The analysis of these substances also represents a novelty in the context of the procedure. All 6,547 samples analysed were negative.

NADA Germany was part of a study on Remote Sampling Systems and another research project on long-term storage strategies at the University of Münster.

### European Games

NADA Germany was part of WADA's Independent Observer Team at the

Poland. The international experts of the Independent Observer Team assessed the implementation of the anti-doping work on site and supported the effectiveness of the tests. The anti-doping programme in Krakow was carried out by the International Testing Agency (ITA) on behalf of the European Olympic Committee (EOC) with the support of the Polish Anti-Doping Organisation (POLADA) and the local organising committee.

### International exchange

At the invitation of the French Anti-Doping Organisation (AFLD), employees from NADA Germany's testing programme met with experts from several National Anti-Doping Organisations (NADOs) from the field of doping testing planning for an exchange in Paris to discuss the latest scientific findings and current topics in testing planning.

Dr Martin Bidlingmaier (Head of the Endocrinology Laboratory, specialist in internal medicine, endocrinologist/diabetologist at the University Hospital of Munich, LMU Klinikum) was appointed as the new Chairman of the honorary Testing Programme Commission by NADA Germany's Supervisory Board. The expertise from the fields of analytics, medicine, training science and athlete knowledge represented in the commission advises the Testing Programme Department on the organisation of doping tests.

# **LEGAL MATTERS**

### **Code Revision**

The current anti-doping regulations, the World Anti-Doping Code (WADC), came into force on 1 January 2021. In autumn 2023, WADA and its stakeholders launched the revision of the WADC. On 1 January 2027, a revised WADC will replace the current version. In a two-year, multi-stage revision process, future-oriented adjustments, legal and substantive updates and requirements will be discussed in the anti-doping community. The aim is to make the rules robust and resilient for the current challenges of the global commitment of anti-doping organisations to fairness, equal opportunities and integrity in sport.

NADA Germany also submitted proposals for amendments during the first stakeholder consultation phase. NADA Germany is primarily concerned with strengthening athletes' rights, simplifying administrative procedures and specifically improving individual topics in the WADC, such as the results management of cases relating to addictive substances or reporting and missed tests and/or filing failures

(Art. 2.4 WADC). In NADA Germany's view, procedural elements such as the further flexibilisation of sanctions in applicable individual cases and measures to end proceedings such as agreements on dispute resolution should be optimised and further developed.

NADA Germany is also involved in the WADA working groups for the revision of the anti-doping regulations. Dr Lars Mortsiefer is heading the drafting team for the new Standard for Intelligence and Investigations. The new standard sets the framework for the investigative work of anti-doping organisations, defines the administrative and content-related requirements and thus supports the intelligent, targeted investigation of doping violations. Currently, there are only a few remarks on the implementation of intelligence & investigations work in WADA's Standard for Testing and Investigations.

**Filing Failures and missed tests** as well as results management and sanction procedures The number of filing failures and

missed tests was again at a high level in 2023. NADA Germany identified a total of 358 filing failures and missed tests in 2023. 215 athletes were upgraded to a higher testing pool.

#### 98 possible anti-doping rule violations

In 2023, NADA Germany investigated 98 cases of possible anti-doping rule violations. NADA Germany opened results management proceedings in 71 cases. NADA Germany issued 24 sanction notices and conducted nine proceedings before the German Court of Arbitration for Sport (DIS), of which a total of eight proceedings dated back to 2022. Three DIS proceedings were concluded. NADA Germany also conducted four proceedings before the Court of Arbitration for Sport (CAS).

# **INTELLIGENCE &** INVESTIGATIONS

### International projects

International co-operation in the field of Intelligence and Investigations is essential for anti-doping investigations. NADA Germany therefore works together with WADA and other anti-doping organisations across borders. In the Anti-Doping Intelligence and Investigations Network (ADIIN) and WADA's Sport Human Intelligence Network (SHIN), NADA Germany also regularly contributes its expertise to the international exchange.

In 2023, NADA Germany was also part of a WADA Intelligence and Investigations project funded by the EU. The aim of the "Intelligence and Investigation Capacity and Capability Building (IICAP)" project is to expand the capacity of intelligence and investigation work of European anti-doping organisations through innovative educational programmes led by experts. It also aims to raise awareness within government investigative authorities of how anti-doping investigations work and at the same time further improve communication between government investigators and anti-doping organisations. The IICAP

project is to be transferred to other continents in the coming years, creating a global network between anti-doping organisations and investigative bodies.

At the invitation of WADA, an employee in NADA Germany's Intelligence & Investigations department took part in the multi-week training programme for Intelligence & Investigations as part of the Global Learning and Development Framework (GLDF) in 2023. GLDF was created to promote the professional development of anti-doping experts. Through specific, standardised training for the various areas of anti-doping work, the programme aims to impart knowledge, skills and competencies in anti-doping work.

#### **National network**

The continuous and intensive exchange with public prosecutors and investigators from customs, the Federal Criminal Police Office (BKA) and individual police departments promotes the effectiveness of anti-doping work in Germany. The two annual exchange meetings organised by NADA Germany help to intensify cooperation.

Around 40 state investigators from all over Germany attended the launch of the independent training and research initiative of the Federal Institute for Sports Science (BISp) and NADA Germany in spring 2023. The initiative serves to institutionalise the anti-doping training programme in the field of Intelligence & Investigations. NADA Germany's annual update for state investigative authorities took place again in autumn with around 45 participants from 14 federal states.

# MEDICINE

### Further education and lectures

In autumn 2023, NADA Germany invited medical doctors to a digital training course for the first time to provide information on medical anti-doping topics. Around 160 participants accepted the invitation and exchanged ideas with NADA Germany's experts. NADA Germany also gave presentations at various congresses, including the Congress of the German Society for Pneumology and the German Congress for Orthopaedics and Trauma Surgery. Anti-doping training courses were also held at various sports associations such as the National Paralympic Committee Germany, the German Athletics Association, the German Handball Federation and the German Ice Hockey Federation. The Medical Department was represented with a presentation at the annual conference "Sports Medicine in Elite Sports" organised by the German Olympic Sports Confederation and at the annual conference of Handball Physicians Germany. NADA Germany's service providers for carrying out doping tests, Professional Worldwide Controls GmbH (PWC) and International Doping Tests & Management AB (IDTM), were trained on medical topics.

### Information on offer

The information on offer was significantly expanded in 2023 with materials and presentations on the topic of asthma sprays in sport. A flyer and a landing page on the NADA Germany website summarise the most important information for asthma therapy on athletes.

In the ongoing #NADAinformiert web seminar series, the employees of the Medical Department provided information on the topics of "What to do in case of illness?" and "Asthma sprays in sport" and presented the WADA Prohibited List 2024.

The NADAmed drug database was translated into English in 2023 and now also offers non-German-speaking athletes the opportunity to check the approximately 1,400 active ingredients and around 2,000 drugs authorised in Germany for doping relevance before taking them. The number of search queries increased again in 2023. The creation of the sample list of authorised drugs in digital and

#### Research

The Medical Department regularly coordinates projects with the two German WADA-accredited anti-doping laboratories on current issues in anti-doping research. In 2023, a research project to validate a potential alternative detection antibody in EPO analysis and a research project to detect the selective androgen receptor modulator (SARM) S-23 after consuming a food supplement contaminated with S-23 were supported.

# **COMMUNICATION &** MARKETING

#### **Public relations and events**

The public was informed about NADA Germany's work in 2023 primarily through events, interviews and by answering enquiries. At the annual press conference in June 2023, which was once again held in Berlin, NADA Germany looked back on its anti-doping work in 2022 and provided an overview of current national and international topics. At the beginning of September, NADA Germany hosted a workshop for anti-doping officers, which was also attended by athletes for the first time. The programme ranged from information on current topics to practical workshops and a panel discussion on the role of anti-doping officers. The workshop for media professionals in November 2023 offered the opportunity to receive further training and talk about current issues with NADA Germany.

#### **Online projects**

The focus online was on the further development of the offering in social networks. Communication via the platforms X (formerly Twitter), Facebook and Instagram was expanded to include LinkedIn. The account helps

to respond more specifically to the various target groups and communicate information. The accessibility of all NADA Germany websites was also reviewed. Accessible internet is a fundamental prerequisite for enabling everyone to access information. NADA Germany is constantly expanding this area.

#### Initiative for clean sport

Last year, NADA Germany used its live tool of the GIVE EVERYTHING, TAKE NOTHING initiative together with visitors and athletes to promote clean sport, for example at the Special Olympics World Games or the EuroHockey Championships. The LET'S TALK ABOUT campaign, which was launched as part of the initiative in 2022, aims to engage in dialogue with athletes and address important values in sport. It was continued in 2023 with the track and field athletes Bianca Stichling, Linn Kleine and Nils Laserich on the values of authenticity, fair play and reliability.

### **Research projects**

# **EDUCATION**

### Achieving more together

NADA Germany's key tasks in 2023 also included doping education and prevention on all anti-doping topics. The new national doping education plan drawn up in 2023 is an important aspect of the design and evaluation of the TOGETHER AGAINST DOPING education programme. In it, NADA Germany documents all relevant target groups, the programme objectives for the relevant group of people and specific learning objectives. The doping education plan is a requirement of WADA's International Standard for Education (ISE). As part of the TOGETHER AGAINST DOPING network, NADA Germany published the doping education plan in 2023 for partners in the sports structures. The relevant contact persons at the associations were thus given the opportunity to understand the prevention programme in its entirety and to request even more precise and target group-specific measures and offers from NADA Germany.

With TOGETHER AGAINST DOPING, NADA Germany continues to pursue a network approach that enables athletes to be supported in anti-doping issues throughout their sporting careers and their environment to be sensitised to clean sport. Associations and clubs from organised sport are firmly anchoring doping prevention in their own institutions. The aim is to reach young athletes as a primary target group at an early stage. The network has continued to grow steadily since its foundation, with 136 institutions being part of the network by the end of 2023.

The TOGETHER AGAINST DOPING network event was once again an important pillar for networking and cooperation in 2023. The approximately 85 participants received the latest impetus from the field of doping prevention in presentations and discussion rounds. They also exchanged ideas in workshops on goals and specific measures in the context of this important topic.


### Training courses and information sheets

In 2023, NADA Germany trained both coaches and parents and provided target group-specific information. In order to ensure that training courses, workshops and information stands on doping education are organised nationwide, the Doping Education Department has a pool of around 60 freelancers at its disposal. The intensive and continuous training of doping prevention freelancers is an important prerequisite for ensuring the high quality of NADA Germany's prevention measures. The freelancers were trained several times by NADA Germany in 2023. The training focussed on both didactics and content.



### Teaching values to the little ones

The Pixi book "Nika wants to win" was developed together with NADA Germany's Communications Department. The short story, which is specially designed for children of nursery and early primary school age, teaches the importance of fair play in a playful way. With a child-friendly language style and appealing illustrations on 24 pages, the book's protagonists a group of children at a sports festival - learn what it means to cheat, admit mistakes and win friendship in the end.



### Expansion of the e-learning programme

The existing range of e-learning courses offered by TOGETHER AGAINST DOPING has been expanded to include a course aimed at NTP and RTP athletes on the use of ADAMS and how to deal with reporting obligations. A new course in simple language serves to inform very young athletes as well as people who are not native German speakers or have language restrictions. The young target group of participants in the European Youth Olympic Festival (EYOF) was prepared for the sporting event with a special course. In addition, the most important information on medication controls for their animals was summarised in an e-learning course for the owners of horses in the Equestrian Federation (FN) squad.



# HUMAN RESOURCES, FINANCE & CONTROLLING

### Business performance and financial position of the Foundation

In the course of the ongoing transition process to institutional funding, procedural adjustments required under grant and procurement law were also made continuously in 2023, applying the General Auxiliary Provisions for Grants for Institutional Funding (ANBest-I).

The federal government contributed to NADA Germany's operations with a grant totalling 6.89 million euros. The federal states jointly contributed to the financing of doping prevention in the amount of 655 thousand euros. Sport made a contribution of around 1.84 million euros.

The total operating budget totalled around 12.64 million euros. This includes federal funds totalling around 2.50 million euros, which were forwarded to the WADA-accredited laboratories in Cologne and Kreischa to finance research and analysis. Inflationary increases in costs and administration, partly as a result of the war in Ukraine, had a negative impact on NADA Germany's 2023 financial year. The costs for doping tests rose due to the regular Europe-wide tenders for service providers to carry out doping tests on NADA Germany's behalf. Nevertheless, NADA Germany succeeded in stepping up preparations for the Olympic and Paralympic Games in Paris 2024. The number of doping tests reached a consistently high level. An impending need to reduce the number of doping tests was averted thanks to an additional federal grant totalling 469 thousand euros. As a result, NADA Germany was able to achieve the same level of testing as in 2022 in the area of in-competition and out-of-competition testing. This results in a positive overall conclusion for the 2023 financial year. The financial support from the federal government, the federal states and sport - in particular the additional, unscheduled increase in funding - made it possible to maintain NADA Germany's operatio-

nal business as planned.

In 2023, the certification was again confirmed by the regular surveillance audit of the NADA Germany office on the proper implementation of the internationally recognised DIN EN ISO 9001:2015 standard.



### International exchange

Cooperation with other National Anti-Doping Organisations (NADOs) is important in order to create equal opportunities for athletes worldwide. NADA Germany is a member of the NADO Leaders Group, which met in Amsterdam in 2023 for an exchange to ensure the appropriate conditions.

Another part of this work is the direct exchange with other anti-doping organisations. In 2023, this included various meetings with the Germanspeaking NADOs from Switzerland and Austria as part of the regular dialogue of the D-A-CH group.

NADA Germany also welcomed international colleagues from all over the world. Sport Integrity Australia and the US Anti-Doping Agency USADA were guests in Bonn for an exchange. The visits focussed on international cooperation for clean and fair sport worldwide.

### International conferences

In 2023, NADA Germany took part in the international symposium of the

Institute for Doping Analysis and Sports Biochemistry Dresden in Kreischa, the celebration of the 50th anniversary of the WADA-accredited laboratory in Ghent, the symposium to mark the 20th anniversary of Antidoping Norway and WADA's Education Summit 2023.

Employees from NADA Germany's Education Department were on site in Vienna for the Advisory Group on Education of the Council of Europe to exchange information on international education work at European level.

# **REPORT 2023 OF THE** DATA PROTECTION OFFICER

External Data Protection Officer of NADA 2023: Dr Ralf Schadowski

### 1. Summary

As the externally appointed data protection officer of the National Anti Doping Agency Germany, I hereby certify that a data protection management system is in place in accordance with the requirements of the applicable Federal Data Protection Act and the European General Data Protection Regulation (EU GDPR).

NADA Germany has undergone an audit based on BSI basic protection and has implemented the recommendations for action. In particular, the following areas are implemented within the scope of the data protection management system (DSMS):

- Order processing in accordance with Art. 28 GDPR
- · Procedure directories in accordance with Art. 30 GDPR
- Appropriate information procedure in accordance with Art. 15 GDPR
- Technical and organisational measures in accordance with Art. 32 GDPR
- Contract review of incoming contracts in the context of data protection
- Employee sensitisation

The DSMS is a structured and systematic framework / methodology that helps NADA Germany to manage, monitor and improve data protection in its business processes and activities. A DSMS is designed to meet an organisation's data protection requirements and obligations, particularly in relation to data protection laws and regulations.

The implementation of a DSMS helps to minimise data protection risks, ensure the protection of personal data and strengthen the trust of athletes, part-

ners, employees and other stakeholders with regard to the handling of their data. A DSMS comprises the following main components (criticality 1), see figure on the right.

The DSMS is permanently available to NADA Germany in the data room at ADDAG's data centre. All documents, guidelines, order processing in accordance with Art. 28 GDPR, procedure directories in accordance with Art. 30 GDPR, etc. are stored there. NADA Germany has access and informs the data protection officer in the event of changes (processes, contractual partners, technology, tools, etc.). The maturity level of data protection requirements at NADA Germany is high and meets the requirements. Important areas are briefly explained below.

#### 2. Status Quo

#### 2.1 Register of processing activities

The register of processing activities in accordance with Art. 30 GDPR is currently complete with 30 procedures / activities described for the following areas:

- Testing Department (DKS)
- Communications Department
- Medicine Department
- Education Department
- Legal Matters
- Administration: Human Resources, IT Support

New procedures are reported to the data protection officer and documented with the responsible department at NADA Germany. Existing processing activities are continuously maintained in the register. The last review of the register of processing activities

was carried out on 14 March 2024.

### 2.2 Fulfilment of information obligations

The data protection notices for websites and portals have been adapted to the requirements and, in the event of a website renewal, additionally checked by website checks. The implementation of a consent process or the existence of a legal basis is always taken into account in any contact.

### 2.3 Dealing with data deletion

Data is erased or blocked after the legal basis ceases to apply or consent is withdrawn, depending on technical feasibility. Erasure requirements are set out in the record of processing activities. The implementation of deletions is organised. Documentation of the organisation in a deletion concept is recommended and must be agreed with the data protection officer for 2023.

### 2.4 Rights of data subjects

The appropriate information procedure has been organised, the data storage locations and contact persons have been identified on the basis of the procedural documentation, the process has been defined and the template for any requests for information has been created. Requests for information are answered appropriately in close cooperation with the data protection officer.

### 2.5 Data protection impact assessments

A data protection impact assessment was carried out for the Microsoft 365 software solution during the reporting period. The measures to mitiga-

### 2.6 Data protection incidents

In the reporting period, there were no reportable data protection incidents or IT security incidents with serious data protection consequences for data subjects. All employees can contact the data protection officer directly 365 days a year / 24 hours a day in the event of data protection incidents in order to comply with the 72-hour reporting obligation.

### 2.7 Order processing agreements

All relevant service providers in terms of order processing in accordance with Art. 28 GDPR were contractually fixed and randomly checked. An overview of the service providers used was compiled in tabular form. The technical and organisational measures and subcontractors used were checked and approved as a minimum guarantee.

### 3. Data protection awareness training provided

Employees are regularly sensitised to data protection. The lists of participants can be viewed on request. The last sensitisation took place on 28.03.2023.

### 4. Change Management

The data protection officer is requested as required, for example in the event of:

- Extensions / changes to IT solutions / IT infrastructure
- Service provider contracts (new creation, changes)
- Process changes in the handling of personal data
- Data protection enquiries from clients / service providers
- Data protection enquiries from athletes / employees / other data subjects

#### 5. Information Security

The responsible organisation underwent a BSI basic protection audit and recommendations for action were implemented. There were no significant IT disruptions / breaches of information security during the reporting period. In 2023, NADA Germany established an ISMS that supports the data protection requirement.

### 6. Training and proof of expertise

The data protection officer Dr Ralf Schadowski is the external data protection officer of the controller. He is personally ISO 17024 / 27701 certified in the area of data protection and is therefore continuously monitored. He supports NADA Germany with 35 data protection specialists from his team, who also have up-to-date training levels depending on the specialist.

#### 7. Other

The data protection measures at NADA Germany will be continued in 2024. In particular, the (possibly digital) employee sensitisation and the necessary review work of the DSMS are being planned. The following measures are also planned for various data protection and IT security documents:




