The foundation National Anti Doping Agency of Germany (NADA Germany) is the relevant institution for clean sport in Germany. It promotes fairness, transparency and equal opportunities for all athletes nationally and internationally. Its tasks comprise the implementation of a standardised testing programme for Germany, execution of education, issuing Therapeutic Use Exemptions (TUEs) and answering medical inquiries, providing legal advice for federations and athletes, as well as international cooperation. NADA Germany essentially contributes to preserving values in sports.

In July 2002, NADA Germany was founded with a festive act in the Old City Hall of Bonn and was recognised by the foundation supervisory authority on the 21st of November in the same year. Since then, it has been pursuing its valuable mission and supports athletes who pursue their sport with integrity. As a non-profit foundation under public law, which has been institutionally supported since January 2020, NADA Germany is an independent body. NADA Germany opposes doping in sports nationally and internationally alike.

REGAINING TRUST IN ANTI-DOPING WORK



Strong international anti-doping work is largely based on standardised and transparent action by all those involved in anti-doping work. In the past year, however, anti-doping work has lost a great deal of trust due to various events. There is an important need to regain this trust. NADA Germany has joined forces with 18 other national anti-doping organisations from all continents. Together, we are calling for constructive dialogue and targeted, transparent and comprehensible

cooperation. This is our duty for clean athletes.

NADA Germany advocates a strong, independent regulatory body. In the current revision of the World Anti-Doping Code, NADA Germany has included this demand. In addition, the revision will further emphasise the work of Intelligence & Investigations. In future, the separate International Standard for Intelligence and Investigations will be included in the sports regulations, and NADA Germany played a key role in formulating it. At the same time, NADA Germany is intensifying its dialogue with athletes and involving them in the review process.

The Anti-Doping Act continues to form an effective basis for NADA Germany's cooperation with state investigative authorities to uncover criminal structures in sport. NADA Germany hopes to consolidate this cooperation, e.g. by establishing and expanding further specialised public prosecutors' offices. It is essential for NADA Germany to regularly subject the management structures of its anti-doping work to an external review. NADA Germany had its work processes and organisational structures evaluated again in 2024 by an independent auditing body and used the certification according to the internationally recognised DIN standard ISO 9001 to improve the quality of its work.

The basis for the implementation of all anti-doping measures is always sufficient funding. In 2024, NADA Germany received an inflation-compensating increase in funding from the federal funding body, thereby sending an important signal for the continuation of NADA Germany's services for doping-free sport.

In order to prevent athletes from taking the wrong path, education measures and doping tests are core areas of NADA Germany's work. Ongoing dialogue with athletes is essential for the further development of antidoping work. With the #PROUDTOBETRUE campaign, NADA Germany has involved athletes for clean sport.

Awareness-raising activities were further strengthened, and both networking and behavioural education activities, such as e-learning, online resources and workshops, were expanded. The educational preparation of Olympic and Paralympic participants and the "Home match for Fairness" education campaign in con-

nection with UEFA EURO 2024 were highlights of the 2024 education work.

Participation in the international committees for the recommendations of test programmes prior to the Olympic and Paralympic Games, the implementation of a pre-Olympic and pre-Paralympic test programme for German athletes and the on-site presence in Paris were important measures of the testing activities and international exchange in 2024.

ENSURING EQUAL OPPORTUNITIES

Athletes are at the center of NADA
Germany's anti-doping work. They have
to submit to unannounced doping tests
every day and fulfill their reporting
obligations. It is therefore NADA
Germany's duty and responsibility to
safeguard the integrity and values of
sport, such as fairness, tolerance and
equal opportunities, on a permanent
level.

In order to introduce young athletes to the values of sport, NADA Germany focuses on information and education. With the TOGETHER AGAINST DOPING network, structural improvements are sought and at the same time targeted measures are offered for athletes and their environment in order to educate specific target groups. Doping tests complement the educational measures and are the focus of constant further development to improve and implement

anti-doping work more efficiently. In addition to advising athletes in German sport, carrying out doping tests and the overall implementation of the WADA regulations together with the top associations, NADA Germany is particularly committed to efficient anti-doping work on an equal footing internationally. It is important that the international anti-doping players pull together for clean sport and to ensure equal opportunities internationally. In 2024, the conflict between the World Anti-Doping Agency (WADA) and the US Anti-Doping Agency (USADA) has created an imbalance in this respect. NADA Germany is therefore working with other international partners to mediate between the different parties and, in particular, to promote strong, harmonized international anti-doping work.

NADA Germany's contribution is indispensable in maintaining and strengthening the values and fascination of sport. Equal opportunities can only be ensured through the continuity of antidoping measures. As the Supervisory Board, we rely on the continued commitment of all stakeholders to ensure that NADA Germany can continue and further expand its successful work for fairness and equal opportunities in German sport in the future for the benefit of clean athletes and to guarantee fair competition conditions.

TESTING

Olympic and Paralympic Games

In the Testing Department, the year 2024 was dominated by the Olympic and Paralympic Games. For the first time, NADA Germany was part of the Pre-Games Expert Group for the Olympic Games and the Anti-Doping Taskforce of the International Paralympic Committee (IPC). The groups were responsible for developing recommendations for an international pre-Olympic and Paralympic testing program. The aim was to collaborate, build and strengthen knowledge and capacity for the implementation of effective Testing and Education Programme.

NADA Germany has implemented an extensive pre-Olympic and Paralympic Testing Programme. Additional analyses, the use of the Athlete Biological Passport (ABP) and the transfer of samples to long-term storage were an integral part of the 2024 Testing Programme.

Further Development

The use of the Dried Blood Spot matrix as a further sample option was significantly increased again in 2024. For the

first time, 881 Dried Blood Spot samples were taken and analysed. In collaboration with the Institute for Doping Analysis and Sports Biochemistry Dresden in Kreischa, NADA Germany re-analysed plasma samples from the Athlete Biological Passport for the first time in order to identify athletes with suspicious EPO profiles and obtain information for current control planning.

Long-term storage and re-analysis

For NADA Germany, the storage of samples is another option for intelligent test planning. In 2024, the sporting highlights were the strategic focus of long-term storage. NADA Germany also responded to current developments and findings from the field of intelligence and investigations work in order to transfer samples to long-term storage. Long-term storage thus supports the unpredictability of testing as a further important element.

Samples can be stored for up to 10 years. For this reason, NADA Germany, in cooperation with the WADA-accredited anti-doping laboratories in Cologne and Kreischa, re-analysed

all samples from 2014 and 2015 that were still in long-term storage. All 339 samples were negative.

International exchange

NADA Germany invited testing experts from various anti-doping organisations to a Testing Experts Meeting in Bonn. Current topics and innovations in testing of the countries represented were discussed. Among other things, the participants summarized the Testing Programmes for the Olympic and Paralympic Games and discussed the strategies for using the Dried Blood Spot method for doping tests.

Regular exchanges took place as part of the D-A-CH cooperation with Austria and Switzerland, including for the establishment of our own network of inspectors.

LEGAL MATTERS

Code Revision and update of the International Standards

Last year, NADA Germany took part in the first stakeholder consultation phase of the revision of the WADC, which will replace the current version on January 1, 2027. NADA Germany's proposed changes mainly related to how the anti-doping regulations can be brought into line with national law. In addition, NADA Germany has adjusted WADA's proposed compliance quidelines for National Anti-Doping Organisations (NADOs), NADA Germany believes that the implementation both in national law and worldwide need to be fullfiled. Another important concern of NADA Germany is the protection of minors. It demands that doping tests are no longer carried out visually on underage athletes. This should help to increase the acceptance of tests among young athletes.

NADA Germany has been supporting the revision process of the Code and the standards at all technical levels since 2023. NADA Germany is represented by Dr Lars Mortsiefer in the WADA working group for the 2027 International Standard for Intelligence and Investigations and will be in charge of drafting and finalising it.

NADA Germany is also contributing its expertise via the Council of Europe.

Updated version of the VAÜ

On January 1, 2024, an updated version of the Rules of Procedure for the Administrative Review of Whereabouts Failures (VAÜ) came into force. The revision was mainly based on editorial adjustments to the 2021 National Anti-Doping Code (NADC21) and the International Standard for Results Management.

Filing Failures and missed tests

In 2024, NADA Germany identified a total of 300 filing failures. Of these, 177 athletes were upgraded to a higher testing pool and 123 athletes received a so-called strike.

93 possible anti-doping rule violations

In total, NADA Germany investigated 93 cases of possible anti-doping rule violations in 2024. Of these, results management proceedings

were initiated in 74 cases. 22 decisions were issued and 5 proceedings were conducted before the German Court of Arbitration for Sport (DIS), 3 of which dated back to 2023 or earlier. Of the proceedings conducted before the DIS, 3 proceedings were concluded. NADA Germany conducted 6 proceedings before the Court of Arbitration for Sport (CAS).

INTELLIGENCE & INVESTIGATIONS

International cooperation

NADA Germany intensified its international Intelligence & Investigations cooperation in 2024. In May, NADA Germany took part in the two-day Sport Human Intelligence Network in Montreal, Canada, at the invitation of WADA. Topics at this meeting included best practice methods in investigative work, guidelines for handling personal data and sources, the global whistleblowing situation and the current revision of the 2027 International Standard for Intelligence and Investigations.

In cooperation with WADA and its partner program, NADA Germany has entered into a partnership with the Azerbaijan National Anti-Doping Agency (AMADA) with a focus on Intelligence & Investigations. The WADA partner program was established to ensure uniform standards in anti-doping work worldwide. It supports countries in need of development to strengthen their anti-doping measures and create fair conditions for all athletes. WADA, NADA Germany and AMADA have develo-

ped a plan for the implementation of the cooperation, which is to be realised in the coming years.

As part of the cooperation between Swiss Sport Integrity, NADA Germany and the Swiss and German investigative authorities, a doping network based in Germany was uncovered and dismantled. Future cooperation was on the agenda at a meeting with the Polish Anti-Doping Organisation (POLADA). Cooperation is to be intensified, particularly in the areas of intelligence & investigations and cross-border testing measures.

Informational events and workshops

The exchange between NADA Germany and the WADA-accredited laboratories with public prosecutors' offices and investigating officers from customs, the Federal Criminal Police Office (BKA) and individual police departments was again promoted by two exchange meetings organised by NADA Germany. These meetings strengthen the joint approach and the effectiveness of national anti-doping work in all areas. Within the Research Initiative on Criminal Doping Law (FIDoS), an event was held at the Justizakademie NRW.

SPEAK UP

In 2024, the anonymous whistleblower system experienced a further increase in the number of accesses and reports. A total of 1,009 accesses to the system and 28 BKMS reports from 12 sports were recorded

MEDICINE

NADA Germany strengthens WADA **Prohibited List Expert Advisory Group**

Dr Anja Scheiff, Head of Medical Department, has been appointed by WADA as a member of the Prohibited List Expert Advisory Group. The group supports WADA in the further development of the WADA Prohibited List and proposes, among other things, which substances and methods should be added to or removed from the WADA Prohibited List.

Cannabinoids after partial legalisation in Germany

Despite the partial legalisation of cannabis and non-synthetic tetrahydrocannabinol (THC), the use of cannabinoids remains prohibited within competitions in accordance with the provisions of the worldwide WADA Prohibited List. The detection of cannabinoids in the context of a competition test can still constitute an anti-doping rule violation and be sanctioned in sport.

Medical information services

NADA Germany continued its digital education program for doctors in 2024 and provided information on current medical anti-doping topics on two dates. It also offered digital training for physiotherapists for the first time. Around 200 interested people took part in each of the training courses. NADA Germany gave presentations on medical anti-doping topics at various events, such as the "Sports Medicine in Elite Sports" conference of the German Olympic Sports Confederation (DOSB) and the conference of the German Medical Associations. In addition, the Medical Department has published two medical information sheets "Cannabis and hemp products in sport" and "Operations on athletes". NADA Germany has developed the TUE Navigator online query tool so that athletes can independently check whether they need to apply for a Therapeutic Use Exemption (TUE) in a specific situation.

Therapeutic Use Exemptions (TUEs) were granted by NADA Germany in 2024, three TUE applications were rejected.

Research projects

NADA Germany regularly cooperates with the WADA-accredited laboratories in Cologne and Kreischa in the development and implementation of research projects. In 2024, the Medical Department initiated a project to analyse various homeopathic medicines for banned substances. NADA Germany also supported five other research projects in which new detection methods were developed for an erythropoietin variant in blood serum samples, for EPO in Dried Blood Spot (DBS) samples and for the growth hormone analogue somatrogon in urine samples, metabolites of the stimulant flmodafinil were characterised and the influence of ashwagandha on the serum steroid profile of the Athlete Biological Passport was investigated

COMMUNICATION & MARKETING

Olympic and Paralympic Games 2024

The 2024 Olympic and Paralympic Games were a special highlight for NADA Germany. It accompanied the Games with various communicative programmes such as the PROUD TO BE TRUE campaign. Skater Lilly Stoephasius, BMX athlete Regula Runge and para table tennis player Valentin Baus showed their clean path to Paris.

At the joint press conference with the French Anti-Doping Organisation (AFLD), the International Testing Agency (ITA) and NADA Austria at the German House in Paris, the focus was on the international harmonisation of anti-doping work. During the Games, NADA Germany was represented at the GIVE EVERYTHING, TAKE NOTHING Live-Tool in the German House and was available to answer questions. The Federal Minister of the Interior and for Home Affairs, Nancy Faeser, also visited the information stand and was given an in-depth insight into NADA Germany's anti-doping work.

Public relations and events

At the annual press conference, NADA Germany provided information about its anti-doping work in 2023. Media representatives also had the opportunity to take part in a workshop for journalists and exchange ideas with NADA Germany in Bonn. The offer to take part in a doping test as a self-experiment met with great interest and was supplemented with a Q&A session with Annika Zeyen-Giles (para-cyclist and Paralympics winner) and Lasse Lührs (triathlete and Olympic champion). NADA Germany was in close contact with the media throughout the year, answering enquiries and giving interviews. NADA Germany also reported on its work via press releases, social networks and its newsletter. NADA Germany continued the #NADAinformiert web seminar series in 2024 and provided information on current topics on a monthly basis. In October, NADA Germany invited the federations' anti-doping officers and athletes to an anti-doping workshop in Bonn to discuss nutritional supplements, doping traps and international anti-doping work.

Research projects

NADA Germany is participating in the research project "Top athletes and the media: an analysis of the perception and evaluation of doping reporting and the subjective perception of physical and mental performance" at the Technical University of Munich. The international research project "Supporting Anti-Doping via Transforming Athletes' Life Experience after Doping into Education Resources and Policy Recommendations (TALE) - What about us" at the University of Innsbruck was continued in 2024.

EDUCATION

Structural education

The TOGETHER AGAINST DOPING network, which is moderated and coordinated by NADA Germany, continued to grow in 2024 with the addition of further national sports associations (LFV) and leagues. As a result, the number of organisations actively involved in shaping doping education in Germany has increased by 18 to 154. In cooperation with the Federal Institute for Sports Science (BISp), NADA Germany hosted the TOGETHER AGAINST DOPING network event. With around 80 participants, the two days of the event led to a lively exchange on topics relating to doping education. In addition to contributions from NADA Germany's specialist departments, the content was supplemented by presentations from two external speakers on the topic of addiction education and the lives of young people. In September, NADA Germany organised a digital meeting for the network's LFVs and clubs for the first time in order to offer another opportunity for exchange and information sharing, especially for representatives who perform this task on a voluntary basis.

Behavioral education

The training courses, workshops and information stands organised by TOGETHER AGAINST DOPING were also key elements of the preventative measures and offers in 2024. More than 9,000 athletes and their families were reached with a total of 486 training courses and workshops. In 2024, NADA Germany further developed its strategy for addressing the school and competitive sport network in particular. In cooperation with the German Olympic Academy (DOA), NADA Germany also organised an advanced training course for around 50 teachers from various types of schools under the motto 'Olympic - Fair - Clean'. In addition to coaches and carers, NADA Germany also trained parents in the athletes' sporting and personal environment. In addition, 126 information stands were organised for youth and junior athletes at regional and national championships and tournaments.

Major sporting events

In a cooperation project with the BISp, NADA Germany accompanied the UEFA EURO2024 with the

'Home Game for Fairness' education campaign. The campaign was part of the 'Home Game for Europe' project initiated by the Federal Ministry of the Interior and Home Affairs (BMI). With targeted education in the host cities, extensive social media activities and the conference 'Over-the-counter and therefore harmless? Food supplements and painkillers in football and other team sports', NADA Germany and BISp promoted equal opportunities, fair play and respect on and off the pitch before and during the tournament. Prior to the Olympic and Paralympic Games, NADA Germany developed and implemented a comprehensive education programme. This included a specially developed e-learning course for participants in the 2024 Olympic and Paralympic Games. The education department also held a workshop together with the French anti-doping organisation (AFLD) as part of the French-German Olympic Youth Camp in Paris.



School network

For NADA Germany, the school and competitive sport network is an important starting point for addressing and sensitising future competitive athletes to fair play and clean sport at an early stage. This is where two central needs of young athletes come together: the optimal development of individual educational potential and the best possible promotion of sporting talent. It is therefore important to NADA Germany to start with education programmes in order to raise awareness of the values of clean sport at an early stage. NADA Germany has developed the new TEACHER & SCHOOL brochure, which provides ideas and concrete offers for the implementation of doping education in everyday school life, gives impulses for one's own role as a teacher in doping education and raises awareness of this important topic.



Virtual reality glasses with 360° videos

At the TOGETHER AGAINST DOPING interaction stands and at workshops and training sessions, visitors and participants can now use virtual reality glasses and 360° videos to gain an immersive impression of athletes' decision-making situations. The interactive elements encourage visitors to reflect on their own values and health. When creating the videos, the main aim was to depict the process of a doping test as realistically as possible using the possibilities of a 360° production and to utilise its advantages.



International exchange

The year 2024 was characterised by an intensified international exchange within the framework of WADA's Global Education Conference, meetings of the Advisory Group on Education of the Council of Europe and bilateral exchanges with NADOs from other countries. The discussions and meetings always centred on dealing with the International Standard for Education (ISE) and the revision of the ISE with validity from 1 January 2027. In October, NADA Germany also took part in the international exchange of the Penrose Education Experts and Resource Sharing (PEERS) group. The focus of the meeting, which was led by USADA, was values-based education work with athletes.

HUMAN RESOURCES, FINANCE & CONTROLLING

Business performance and financial position of the Foundation

After NADA Germany's former
Chairperson of the Executive Board,
Dr Andrea Gotzmann, retired in 2023,
Dr Lars Mortsiefer was appointed
Chairperson of the Executive Board
in September 2023 (with responsibility for Legal Matters and the function
of Chief Legal Officer) and in February 2024 the Supervisory Board appointed Dr Eva Bunthoff as a member of
the Executive Board. At the same time,
Dr Bunthoff took over the management of NADA Germany's Testing.

In 2024, the necessary procedural adjustments to business operations were also made on an ongoing basis in accordance with grant and public procurement law, applying the General Auxiliary Provisions for Grants for Institutional Funding (ANBest-I). The federal government contributed to NADA Germany's operations with a grant totalling EUR 7.34 million. The federal states jointly contributed EUR 648 thousand to the financing of doping education. Sport made a contri-

bution of around 1.71 million euros. The total budget for the operating business totalled around 13.03 million euros. This includes federal funds totalling around 2.8 million euros, which were forwarded to the WADA-accredited laboratories in Cologne and Kreischa to finance research and analysis.

In 2024, NADA Germany received an inflation-compensating increase from the federal funding body for the implementation of all anti-doping measures, which sent an important signal for the continuous continuation of NADA Germany's services for doping-free sport. As a result, NADA Germany was able to level out the cost increase in the area of testing and achieve an almost constant testing density in the area of training and competition testing. NADA Germany has also further strengthened its information and education work. Both measures aimed at structural education in the context of networking and measures aimed at behavioral education, such as e-learning

and workshops, were expanded. This results in a positive overall conclusion for the 2024 financial year. The financial support from the federal government, federal states and sport enabled NADA Germany to maintain its operational business as planned.

In 2024, the certification was again confirmed by the regular surveillance audit of the NADA Germany office on the proper implementation of the internationally recognised DIN EN ISO 9001:2015 standard.

As at 31 December 2024, NADA Germany had 39 full-time employees, 5 part-time employees and seven part-time employees.

INTERNATIONAL COOPERATION

International cooperation

NADA Germany is actively engaged in exchange and cooperation with other NADOs to promote equal opportunities for athletes worldwide.

NADA Germany is strengthening its cooperation at European level: an agreement was signed with the Polish Anti-Doping Organisation (POLADA). In addition, a transnational cooperation agreement was concluded with the National Anti-Doping Organisation of East Belgium (NADO East Belgium) and the AFLD.

In 2024, NADA Germany also extended its cooperation with the ITA in the areas of testing and Intelligence & Investigations.

Visits from all over the world

NADA Germany welcomed international guests in 2024, thereby deepening its global network.

At European level, representatives from the Institute of National Anti-Doping Organisations (iNADO), the Norwegian Anti-Doping Organisation (ADNO), the Finnish Centre

for Integrity in Sport (FINCIS), the AFLD and NADO East Belgium visited the office in Bonn. NADA Germany also welcomed delegations from the national anti-doping organisations of New Zealand and Azerbaijan.

International conferences and training courses

NADA Germany took part in the WADA Symposium in Switzerland in 2024 and used the event to exchange ideas with international partner organisations. It also gave talks and presented its work at the iNADO General Assembly in Switzerland and at the Play the Game conference in Norway, for example.

In addition, NADA Germany was part of a delegation of the Council of Europe's Monitoring Group and participated in the evaluation of the implementation of the Anti-Doping Convention in Austria. NADA Germany also took part in various NADO Leader Meetings in order to react as one to the positive cases in Chinese swimming and the conflict between WADA and the USADA.

NADA Germany also held important dialogue meetings with the International Olympic Committee (IOC) and the ITA in Switzerland. The close cooperation in the D-A-CH group was further strengthened through regular consultations with the managing directors of the anti-doping organisations from Austria and Switzerland.

REPORT 2024 OF THE DATA PROTECTION OFFICER

External Data Protection Officer of NADA Germany 2024: Dr Bettina Kraft

Summary

The controller National Anti Doping Agency of Germany (NADA Germany), Heussallee 38, 53113 Bonn, operates a functioning data protection management system (DSMS), which implements the requirements of the General Data Protection Regulation (GDPR) and the Federal Data Protection Act (BDSG). As part of an audit based on BSI basic protection / BDSG / GDPR, recommendations for action were defined, which were promptly implemented by the responsible party.

The following areas are maintained in the DSMS:

- Order processing in accordance with Art. 28 GDPR
- Records of processing activities in accordance with Art. 30 GDPR
- Appropriate information in accordance with Chapter III GDPR
- Technical and organisational measures in accordance with Art. 25, 32 GDPR
- Employee awareness training
- ...

The DSMS is a structured and systematic framework / methodology that supports NADA Germany in managing, monitoring and improving data protection in its business processes and activities. A DSMS is designed to meet an organisation's data protection requirements and obligations, particularly in relation to data protection laws and regulations.

The implementation of a DSMS helps to minimise data protection risks, ensure the protection of personal data and strengthen the trust of athletes, partners, employees and other stakeholders with regard to the handling of their data.

The DSMS is permanently available to NADA Germany in the data room of SITS Deutschland GmbH in the data centre. All documents, guidelines, commissioned processing pursuant to Art. 28 GDPR, records of processing activities pursuant to Art. 30 GDPR, etc. are stored there. NADA Germany has access and informs the data protection officer in the event of changes (processes, contractual partners, technology, tools, etc.). The maturity level of data protection requirements at NADA Germany is high and meets the requirements. Important areas are briefly explained below.

Register of processing activities

The list of processing activities in accordance with Art. 30 GDPR is currently available with 30 procedures / activities described for the following areas

- Testing
- Communications & Marketing
- Medicine Department
- Education Department
- Legal Matters
- Administration: Human Resources, IT Support

New procedures are reported to the data protection officer and documented with the responsible department at NADA Germany. Existing processing activities are continuously maintained in the register. The last review of the register of processing activities was carried out on 19 March 2025.

Fulfilment of information obligations

The data protection notices for websites and portals have been adapted in line with the requirements and, in the event of website renewal, additionally reviewed by means of website checks. The implementation of a consent process or the existence of a legal basis is always taken into account for any contact.

Dealing with data deletion

Data is erased or blocked after the legal basis ceases to apply or consent is withdrawn, depending on technical feasibility. Erasure requirements are set out in the record of processing activities. The implementation of deletions is organised.

Rights of data subjects

The appropriate information procedure has been organised, the data storage locations and contact persons have been identified on the basis of the procedural documentation, the process has been defined and the template for any requests for information has been created. Requests for information are answered appropriately in close cooperation with the data protection officer.

Data protection impact assessments

During the reporting period, a data protection impact assessment was carried out for the expansion of the Microsoft 365 software solution. The measures to mitigate the risks were quickly implemented by the IT service provider.

Data protection incidents

During the reporting period, there were no reportable data protection incidents or IT security incidents with serious data protection consequences for data subjects. All employees contact the data protection officer in the event of data protection incidents in order to comply with the 72-hour reporting obligation.

Order processing agreements

All relevant service providers in terms of order processing in accordance with Art. 28 GDPR were contractually fixed and randomly checked. An overview of the service providers used was compiled in tabular form. The technical and organisational measures and subcontractors used were checked and approved as a minimum guarantee.

Data protection awareness training provided

Employees are regularly sensitised to data protection. The lists of participants can be viewed if required.

Assessment of the current status and recommendations for next reporting period

The operation of the data protection management system is being continued intensively. One data protection incident was reported in the reporting period. This did not result in a report to the competent supervisory authority in accordance with Art. 35 GDPR. This initially indicates suitable and effective technical and organisational measures. This also shows that the reporting and notification processes at NADA Germany are working.

The direct involvement of the data protection officer in the processes on an ad hoc basis confirms the successful sensitisation of employees. The cooperation between the coordination team and the contact persons at SITS Deutschland GmbH works well.

The core element of a data protection management system is continuous improvement, for which measures already taken must be regularly checked for completeness and effectiveness.

In addition, new regulatory requirements and changes to the systems must be assessed and implemented. It is therefore important to provide with sufficient resources for regular tasks (such as planned jour fixes, DP audits, data subject enquiries, records of processing activities and possible data breaches) as well as for tasks that arise at short notice.

The following is therefore recommended for the coming reporting period


- · Review and complete the processing directory including risk assessments
- On-site inspection to understand the local conditions and check the technical and organisational measures
- · Conduct awareness-raising/training, in particular to support employees in the context of the DSMS, as these are also relevant to ISMS requirements
- Conduct emergency exercises (DS incident, IS incident, ransom ware attack, phishing attack)
- Check documents for completeness (e.g. consent, data protection information)
